Dr. Sushmita Bhatnagar chaired the meeting.

Founder members are the members who joined the scheme till Dec 31, 2004

1) Status quo of 80:20 payment scheme to beneficiary shall be maintained.

- Founder members after completion of 20 years in CBS shall pay 50% i.e. Rs. 500/- per death as contribution for five more years.
- Those who have completed 25 years in CBS, shall pay 50% i.e. Rs. 500/- per death for next five years.
- Even if these two categories don't contribute, they shall continue to be member of CBS. Amount accrued shall be deducted with interest from final payment to beneficiaries.
- Those founder members unable to pay such amount, this amount will be deducted with prevailing interest at the time of final disbursal of benevolent fund amount.
- 2) Surrender scheme shall be restarted with modification with immediate effect.

 Till 21st July 2024: those who surrender after 10 years in CBS shall be paid 12.5%+security deposit, those after 15 years shall be paid 20%+security deposit, those after 20 years shall be paid 40%+security deposit. The original percentage of 25%, 40% & 50% subjectively shall be relaunched on 21st July 2024 at AGM of CBS; subjective to the financial viability of scheme and after opinion if the actuaries.

 Surrender requests received after March of every year shall be considered on 1st October of every year for final decision on amount payable on surrender. This is the window period for safety of the scheme.
