#### **ELIGIBILITY CRITERIA:**

- 1. For Managing Committee Member's post, minimum duration of AMC Mumbai membership is for 12 months, with no dues.
- 2. For Office Bearer's post, minimum requirement is 3 years of holding Elected Managing Committee Member, with no dues.
- 3. For President-Elect/Vice President's post, minimum requirement is 3 years of holding Office Bearers post, out of which one should be Secretary/Treasurer.
- 4. One can contest for Area Representative only from the area, as per one's mailing address as on Dec.31, 2022 in AMC records.
  - One can file nominations for any number of posts, but can contest only for one post of Area Representative & / or one post of Office Bearer. [Separate forms must be submitted for 2 different nominations.] Xerox copy of the nomination form may be used in such a case.

## CODE OF CONDUCT FOR THE CONTESTANTS FOR ONLINE VOTING FOR OFFICE BEARER AND MANAGING COMMITTEE POSTS 2023-24

The Code of Conduct becomes effective on 8<sup>th</sup> March 2023 and will continue till the announcement of results at AGM on 26<sup>th</sup> March 2023.

The candidates and their supporters should adhere to all moral standards during their campaign and show respect and courtesy to one another, conduct themselves with fair play and ethics.

- 1) No negative campaigning by the candidates is allowed
- 2) Campaigning can be done via social media such as SMS, WhatsApp, Email and Facebook.
- 3) Campaigning cannot be done on the official AMC WhatsApp groups

There are area wise official AMC WhatsApp groups. Campaigning cannot be done on these WhatsApp groups either by the candidate or their supporters. In case a candidate is found canvassing on these groups their name will be removed temporarily until the declaration of result and will be added back on **1st April 2023**. The similar procedure will be followed for a member doing campaigning for a particular candidate in the AMC WhatsApp group. In this interim period should a member temporarily removed wish to send an official message to the other members in the group he can send it via the admin – AMC office.

AMC office will send out one email to all the members before the start of the elections notifying the candidates

- 4) At no cost should AMC finances be used for campaigning.
- 5) If any complaint is received against any candidate, then the decision regarding the candidature of the candidate is the prerogative of the Returning Officers and will be binding.

#### **President's Report**

#### **Dear AMCITES**

Thank you very much from the very bottom of my heart, for the love given to me throughout the year. As I end my year, my heart is filled with satisfaction that I did my best. I did, what I did, pouring my heart & soul into it. That was in my hands. Despite multiple set backs in my personal life, and road blocks created by stalwarts, I managed to see them as spring boards to achieve what I had set out to do.

Many lessons learnt this year . I have become much much wiser in this year than any other year of my life . I grew as a person . I learned to ignore those who were hindering my path because of ego clashes . I learned to look beyond my own ego & give a helping hand to those who were misunderstood . I learned to say a firm NO , where I saw people were doing only things at face value . Learnt to look beyond the facades created .

A very sad way of hindering work in an association is to take up a job & not do it. Just keep procrastinating so that it cannot be handed over to another capable person who would actually do it. Learnt to delegate these jobs to other deserving people or took it up on myself to start work. A lot of time got wasted in believing in these kind of people.

A lot of projects started with a good heart . They may not be able to be completed this year . But the aim is for the Association to grow . I hope these projects are taken to their completion by the incoming team . Registration of hospitals as NTROCs , FEQH accreditation to be recognised by IRDA & insurance companies , Police & Dr Co operation in zones of Mumbai , MPCB issue , Nurses training modules , CPR Videos , Police SOPs for violence against Doctors , Fire drills in various AMC Zones etc . A lot of hard work gone into all this . Writ Petition , if needed to solve the MPCB issue is in the process of finalization .

Single window registration under the ABDM is a coveted dream . We have created the white paper and spoken to govt agencies . If I am able to deliver that ..... It shall be a dream come true for me!

This year has seen a plethora of diverse events covering all aspects of a doctors life . We dabbled in academics for the first time in AMC . We also hand held the peripheral hospitals doing skilled surgical work like laparoscopies & laser therapies .

Marathon , Cyclethon & Bikethon was also done for the first time in AMC . All programs had awareness themes . Awareness on child nutrition , TB , DM , Road safety , organ & blood donation , Give way to Ambulance etc . Tree plantation for every member on his birthday was also a unique concept . The much awaited AMCON was held at the FM Majestic grounds on the 25 th & 26 th of February , after a gap of 2 yrs .... It was after all the 51 St year of AMC .

This was an AMCON With a difference . Fantastic venue , good food , superlative speakers , good topics , each speaker spoken to about the content , no film stars , no politicians , no judiciary ...... Only & only celebration of doctors. For the first time in AMC we stepped out of the 7 star hotel culture . Our theme was ASTITVA .... A MEANINGFUL LIFE . The first day was dedicated to the health & wellness of the fraternity . And the second day , to what a doctor can do productively & effectively if he is healthy himself .

We had Dr Prakash Baba Amte & Dr Mandakini Amte as our Chief guests and Lt General Dr Madhuri Kanitkar as our key note speaker . She was accompanied by her husband Lt Gen Rajeev Kanitkar . Both got standing ovations after their respective speeches and they were our true heroes . Dr Madhuri Kanitkar showed us what one woman with grit , determination & discipline can do in a short span of time . She has changed the face of the MUHS within one year of taking over as Vice Chancellor . Dr Prakash baba spoke about his life .... EK ZINDAGI AISI BHI ...... A selfless path difficult to emulate . We chose a few other deserving doctors trying to live a life beyond medicine , and felicitated them as role models . Dr Anand Parihar was the first amongst them to be felicitated . A man silently working for the over all well being of the cancer patients . Dr Abhay Nene cyclist mountaineer , musician .... Dr Girish Dani

writer, Director, actor ..... Dr Nikhil Datar .... Judicial activist who changed the abortion law of the land .... Dr Tushar Shah, stand up comedian, shayar & teacher ..... Dr Anil Suchak, a living example of a how productive a man can be even after 16 yrs of liver transplant .... Were all felicitated. We also gave recognition to the Fire Department, the Police department, the MPCB & BMC for all the help & co operation that they offered us this year.

A total of 15.5 lakh worth of donations have been made this year  $\dots$  3 lakhs for tree plantation , 1.5 for hearing aids , 7 lakhs to Prakash Baba's Anandvan , 3 lakhs to Madat Trust for cancer patient support & one lakh for the village adoption scheme . We endeavour to give more till the end of March 2023 from the program committee account .

Our year began with major setbacks when our accountant of 15 yrs suddenly left us when uncomfortable questions were asked . But we were able to bring in a new accoutant who did a great job too . A lot of back log we were able to clear out . Digitization of AMC records was taken up in a major way. The working of the office and the lost comeraderie was brought back with love & care . The staff supported me completely thru the year .

When I took over as President, my main worry was the Program account. Programs can be conducted only thru that account. And I have no pharma or any other connect.

But the good Lord up there must be meherban on me.

I got Academic sponsorships just because people came to know that I am taking over as President . My reputation worked for me . The partners were assured of their money being put to good use . I did not have to ask for anything from anyone . AMC is an organization to recon with ... We are a 13 k strong body . So it was a win win situation for all . I chose the partners well too . For me , ethics is more important than the money . So not everyone who came forward , was taken on board . I rejected quite a few too . Our President Dr Nilima did exactly that & year 2022-23 started.

We all together dared to do different things differently.

We gave 34 programs in 11 months with 18 CME Points. Many new initiatives were taken up, like

- Tree plantation in the name of a member on his or her birthday,
- NTROC (organ transplant ), thereby bringing private practitioners on the map of ZTTC
- FEQH ASNH revived so that Insurance Companies shall recognise AMC formulated accreditation norms (efforts of all previous AMC MC Teams) for cashless services alongside NABH.
- Single Window Registration for Nursing Home. White paper on the subject matter submitted to EHO Dr Gomre.
- Initiated and near completion contentious issue of compliance with MPCB. Now AMC is officially part of Govt. Committee of MPCB
- Fresh steps taken for partnering with Police & Fire Department. Very soon Sop's will be issued by Police Commissioner's office to all police stations helping Medical Fraternity & Establishments against violence.
- As a part of Social Responsibility Awareness Programs were taken up via Marathon, Cyclethon & Bikethon. Campaign posters about "Give Way To Ambulance" distributed to members to paste on their cars.

Rs 15 lakhs donated to worthy charitable organisations from the collections of programs conducted during the year. (In turn AMC got 80 G benefit also )

- I am sure all of you remember AMCON, with Dr Prakash Baba Amte as Chief Guest & MUHS Vice Chancellor Retired Lt General Dr Madhuri Kanitkar as keynote speaker. Two days of academic feast with fantastic Speakers on topics touching Physical & Mental Health of the fraternity will be remembered as hallmark of year 2022-23.
- On office front, hardware of all computers was upgraded thereby improving efficiency of staff. Digitization of all records of AMC has started. All annual maintenance contracts renewed with saving cost towards expenses for office expenditure.

Many things for betterment are initiated, many will need continuous follow up. Many new things may prop up.

## Agenda No.7: To receive and adopt the audited balance sheet and the income expenditure statements for the year 2020-2021.

Prof. Dr. Sushmita Bhatnagar informed that this is a part of AGM report and has been circulated. The house unanimously agreed to receive and adopt the audited balance sheet.

#### Agenda No.8: To appoint Auditors for the year 2022-2023.

Dr. Sushmita Bhatnagar informed the house that Mr. Narayan Toshniwal is the internal auditor and Mr. Raman Jokhakar is the external auditor. She proposed the same auditors for the year 2022 - 2023. The proposal was unanimously accepted by all.

#### Agenda No.14: Letters & Circulars.

Dr. Sushmita Bhatnagar said that there are no letters and circulars to be discussed and presented in this meeting.

## Agenda No.15: Any other matter with the Permission of the Chair pertaining to aims and objectives.

- 1. Dr. Dhiren Kalawadia emphasized the importance of getting the audited accounts circulated by email to MC, discussed and passed in a Special AGM, before the AGM. He added that it will not be appropriate to pass the balance sheet without proper discussion. (Unable to understand audio). Dr. Sushmita Bhatnagar said that this is a good suggestion and it will be taken up at a higher level this year.
- 2. Dr. Nitin Bhatnagar's informed about email he had sent regarding attendance criteria of MC meetings. He mentioned that since the attendance criteria was not adhered to during the election process, AMC should do away with the 60% attendance eligibility. Dr. Ashok Shukla mentioned

that since it requires constitutional amendment, it will be taken in future meeting. Dr. Niranjan Agarwal said that there was no waiver of attendanceclause. As we did not have the record of attendance available benefit of doubt was passed to the members. Dr. Kishore Adyanthaya added that two meetings were physical and the rest four were virtual. There was no evidence of attendance of virtual meetings to confirm. It was not possible to go through the video recording at that time and see. He also said that less number of applications were received for the posts of area representatives. As it is now there are six vacancies; would have become twelve if we were to be strict on attendance criteria. Dr. Sujata Rao explained that the meeting was held with good participation of Managing Trustee, four trustees, President, Secretary and President Elect attending. After going through the applications we found them to be inadequate in number. Before rejection on the basis of lack of attendance, the Jt. Secretaries were called to provide the proof of attendance. In a virtual meeting it is only the screenshots can be taken as evidence. None could be obtained at the time of meeting.Dr. Sushmita Bhatnagar said that some criteria must be set. Dr. Nitin Bhatnagar further discussed that the attendance of previous MC meeting is always sent with the minutes. No member has ever complained that his/her name is missing in the list of attendees, in this year. Dr. Nilima suggested that before the last MC meeting all the members must be given information about their attendance status, giving them an opportunity to better the status, if there is a shortfall. Dr. Qayum Mukaddam informed the house, how the attendance is recorded in corporate offices through google forms which is a foolproof method of attendance. Meeting between at 8:45 a.m. however due to lack of Coram it was postponed to 9:00 a.m. At 9:00 a.m. meeting was reconvened, with secretary Dr. Hemant Dugad welcoming attendees.

Dr. Nilima Vaidya Bhamare informed everyone that for the first time the audited accounts were bring presented before the stipulated date, that is 31st September. Procedure demands that auditor accounts be presented in front of the AGM and passed and usually the newly appointed treasurer does the same. Dr. Vikram Khanna will be presenting the accounts. However previous treasurer Dr. Rajendra Nagarkatti and office bearers are free to make their comments and also they are present to solve any queries from the floor.

Treasure Dr Vikram Khanna informed the floor that The Audited Accounts of AMC 2021-2022 have been uploaded on AMC Website. No official queries have been received as of now, but if any queries can be addressed now. Aim of this AGM is to pass the audited accounts so that the CA can submit them for tax returns purposes. He informed that this was possible due to the persistent diligence of Dr Dhiren Kalawadia office Secretary of the present term. It is a historic moment for AMC.

Dr. Sushmita Bhatnagar, IPP informed that page 1 para 3 - our accounts are audited at least twice and hence the term "Inherent limitations of internal control, unavoidable risk of material misstatements may or may not be

detected", should not be present in this statement. She was not sure whether these terms are used as a routine. Is such terms are used than there is no point served in having such detailed reviews and discussing it in AGM.

- Dr. Hemant Dugad responded that this query should be presented to auditor. Usually these are disclaimers put in most routine reports.
- Dr. Sushmita responded that she had sent email 2 days ago in reply mode of presidents email.
- Dr. Vikram informed that this is routine statement of auditor reports and similar statements are used in auditor reports of other charitable organisations also.
- Dr. Sushmita ask whether this means that entire onus is on the office bearers and no responsibility rests with the auditor.
- Dr. Nilima Vaidya Bhamare asked Dr. Sushmita whether she could recall if similar statement was present in previous years audited report.
- Dr. Sushmita responded that she didn't recall. Since we are now taking additional steps so why auditor should have no responsibility.
- Dr. Nilima Vaidya Bhamare responded that this is not an additional step and this should have been done previously also this is probably routine disclaimer and we should pass the rest of the accounts and get back to the auditor on this. We can study previous reports also.
- Dr. Sushmita said that the aim is to reduce these limitations to the minimum.
- Dr. Anukant Mittal remarked that disclaimer is routinely put by auditors with respect to the income tax department in case some queries may arise from income tax department in future. It does not reflect in anyway on our accounting or spending practices.
- Dr. Dhiren Kalawadia clarified that the auditor relies on material given by office bearers and accountant. Hence he puts a disclaimer since he has not seen every document that is presented here. This is the practice of all auditors..So there is no need to worry.
- Dr. Nilima Vaidya Bhamare further added that the purpose of this exercise is to present accounts to the previous office bearers who know the details of it and authenticate it from them before being signed by the current office bearers. Disclaimer is valid.
- Dr. Vikram informed that the next para is self explanatory and dispels all doubts.
- Dr. Suhas Kate raised his hand but was unavailable for making any comments.
- Dr. Vikram continued with presenting report.
- Dr. Nilima Vaidya Bhamare said that she hoped that all those who are present have read the documents sent on email. She added that it was safer to send a link rather than sending the document.
- She also brought the balance sheets to the notice of the house. She further mentioned that they were not yet signed as AGM approval was awaited.
- Dr. Vikram then display the schedule C showing fixed assets and mentioned that there was no deletion this year.
- Dr. Nilima Vaidya Bhamare added that new office premises were added to AMC assets.
- Dr. Sushmita said that she expected that all accounts have been scrutinized by Office bearers, office manager and account, since it is difficult to check whether the accounts are correct or not at one sight since there are several

headings under which accounting is done and the records are available only in office. Also massive amount of transaction take place. So we will go by whatever has been presented and that she has no objection to passing these accounts if the treasurer, office staff and accountant have checked it properly.

Dr. Anukant Mittal said that it is assumed that the office staff are expected to work with previous and present office bearers and due diligence is expected to have been carried. We change the auditor every 3 years as per norms and newly appointed auditor is expected to look into the past accounts for correctness. We go with the assumption that previous office bearers and auditor have looked into the details.

Dr. Vikram reiterated that Dr. Anukant has raised a valid point and he informed the floor that the office staff and auditor of the previous year have prepared the audit report and balance sheets this year, assuring continuity. Most office bearers of present term have also been office where is in previous term and hence work continuity and transparency assured.

Dr. Hemant Dugad pointed out that in spite of having auditor and system in place, why we have to pay penalty is a question to be addressed. There is one figure of excess TDS and also GST penalty. We should look into the matter as to why these lapses have occurred.

Dr. Anukant replied that TDS is deposited by vendors in our names. If they have claimed in excess then we can claim the amount back. We need to find the main amount on which the TDS has been claimed. The late fee is the GST on penalty and is levied on some fees that we have inadvertently paid late and needs to be looked into. If we have paid on time, we can claim the late fee.

Dr. Nilima Vaidya Bhamare requested past treasurer Dr Rajendra Nagarkatti and present treasurer Dr Vikram Khanna to look into the matter so that we can ask our auditor.

Dr. Vikram informed the house that Schedule 9 c and d are statutory requirements which need to be filled up.

Dr. Sushmita mentioned that the accountants were informed last year to change the address, however these accounts still show old address. She asked whether the accountants have not taken not of the same.

Dr Vikram responded that the financial year began in the old premises and we shifted to new office mid-year, hence old address will continue this year. New address will be added from next financial year.

Dr. Sushmita mentioned to follow up with the accountants to change the address on PAN card and all registration documents.

Dr. Hemant Dugad responded that trust address will have to be changed in charity commissioner Office. Office address and trust address can be different.

Dr. Sushmita added that the address mentioned on the pan card is also mentioned in accounts and hence address needs to be changed on PAN card as well.

Dr. Nilima Vaidya Bhamare added that communication address have been changed to new address. Registered address however is still the old address which is also mentioned on PAN Card. Charity commissioner Office work is in process and ones charity commissioner gives permission, address will be changed on all documents.

Dr. Vikram added that schedule 9 D is regarding KYC of trustees. Since there were no further queries the report was accepted. Proposed by Dr. Anukant Mittal seconded by Dr. Suhas Kate and Dr. Ashok Shukla and passed unanimously.

Dr. Kate congratulated the president and secretary for successfully conducting special General body meeting.

Dr. Sushmita asked whether there is a minimum number of attendees required for special AGM.

Dr. Mittal inform that for any Association a special AGM with specific agenda is convened at scheduled time as per notice. In case of insufficient quorum, it is adjourned for 15 minutes and reconvened and at that time, whosoever is present is considered as quorum for the meeting.

Dr. Nilima Vaidya Bhamare further added that no minimum number is mentioned. Dr. Vikram reiterated the above facts.

Dr. Dhiren Kalawadia applauded the effort of the treasurer Dr. Vikram and previous and current team. As per new rules, 80 G and 12 A certificates need to be renewed. He wanted to know whether this process has been done. He further enquired whether change report has been sent to charity commissioner on yearly basis.

Dr. Nilima Vaidya Bhamare responded that it was brought to our notice at the beginning of this year and hence the needful has been done. Dr. Vikram and Dr. Nilima Vaidya Bhamare responded that both 12A and 80F certificates have been renewed.

Dr. Nilima Vaidya Bhamare appreciated that Dr Dhiren's inputs have been very useful and hence the work has been completed with help of accountant and auditor. It was a herculean task but was completed on time. She also applauded Dr. Vikram for taking his task very seriously and completed his work with help of secretary and President. She further appreciated pass president Dr Sushmita for setting a good precedent and that the current team is carrying forward the same. She hoped that the next team will continue in the same vein.

Dr. Hemant Dugad commented that we should try to finish this job earlier to August and present it to AGM.

Dr. Nilima Vaidya Bhamare responded that previous Accountant had promised to submit accounts by June. Our team has been persistent in following up the same. Dr. Nilima Vaidya Bhamare requested all attendees to attend forthcoming AMC programs like Fincon, Marathon, Cyclothon etc.



#### **OUR NEW RESOULATIONS FOR 2021-2022**

- 1) CSI shall be reduced in chronic cases e.g. CKD, Heart ailments etc.
- 2) Co-payment of 10% above age of 55 years for all the cases excluding capping disorders/diseases shall continue.
- 3) No loading in all claims in all age groups.
- 4) Premia are suitable re organised according to age groups.
- 5) Cataract, Hysterectomy, Malignancy & Cardiac illness not covered in initial 2 years for all and 3 years for those above age of 55 years. Hysterectomy and malignancy is fully covered from 3<sup>rd</sup> years onwards provided you have joined scheme below the age of 55 years. Otherwise it will be eligible from 4<sup>th</sup> year onwards only.
- 6) Those in scheme for more than 5 years will no claims in 5 years shall have Co-Payment of 5%. Those with no claims in past 10 years, no Co-Payment is payable.
- 7) Age limit for dependents raised to 70 years from 60 years.
- 8) Completed age will be considered for insurance; instead of running age.
- 9) Minimum CSI allowed is 3 lacs.

#### Medico-Legal Cell Report.

All Members are well aware that the new Consumer Protection Act 2019 has been notified and is now in force. It has made life more difficult for us. It gives the patient the right to file a case against any doctor not only in the jurisdiction of the hospital/clinic where you practice but also in the jurisdiction area of his or her residence (this means the patient from Bihar can sue you either in Bihar and in Mumbai) Instances of Doctors receiving notices to appear before Courts in remote places of the country are now not uncommon.

#### FEATURES OF AMCS MEDICO LEGAL SCHEME:

- 1) End to end in-house scheme management by AMC.
- 2) The AOY:AOI Ratio for our policy is 1:1. This is most important in our P.I. Ins. Policy as it means you are covered for the full sum insured for every case filed against you.
- 3) Provision for out of court settlement in appropriate cases as determined by Medico Legal Cell on the advice from the AMC panel lawyers on a reimbursement basis.
- 4) Exclusive expert Medico legal advisory services rendered by AMC Medico legal cell.
- 5) Expert Advocates appointed exclusively for AMC Members approved and authorized by The Oriental Insurance Co-Ltd.
- 6) Complimentary additional 25% coverage over and above the sum insured from the insurance company. The complimentary additional coverage will be available for sum insured beyond Rs. 50 Lakhs subject to a maximum of Rs. 2 corers sum insured taken from the Insurance Company.
- 7) Professional Indemnity Insurance policy is offered by The Oriental Insurance Company with below key features.
- A. Complaints before MMC, NHRC & Competition Commission of India (CCI) covered under policy.
- B. Defence costs for criminal cases arising out of medical accidents mishaps& operative deaths etc. covered on a reimbursement basis (except 17 exclusions for criminal cases).
- 8) Cashless service for payment to AMC panel advocates as per schedule of fees. Cashless of decreed amount before appeal to the higher forums in case of awards against our members.
- 9) Cosmetic procedures & surgery covered at an extra premium. Cashless of decreed amount before appeal to the higher forums in case of awards against doctors.
  - Travelling expenses for attending National Commission/outside the headquarters for evidence etc. covered.
- 10) AMC scheme provides for hiring expert lawyers and top doctors as Expert witnesses if required in some of the cases on the recommendation of the AMC Medico legal cell. Adv. Fees will be paid with no loading on the members.
- 11) AMC scheme provides for "Out of Court" settlements. Settlements up to Rs. 10 lakhs purely on the recommendations of the AMC Medico legal cell and higher amounts in consultations with the Insurance company lawyers.
- 12) Recent trend has been for patients to file complaints in multiple forums like MMC, FDA Human Rights Commission, Competition Commission, etc. The AMC PI Scheme covers lump sum cost for these forums.

- 13) AMC has A dedicated team for processing of claims and members need not interact directly with the Insurance Company. The solid experience of more than 4 decades backed with a system in place for processing claims makes our AMC scheme much comfortable.
- 14) AMC scheme is now available on a mobile app wherein you can make payments, download your receipts, policy copies or even upload claim forms. The app provides you the best solution of managing your policy at a glance.

In the new fiscal due to our negotiations with the Insurance Company we have been able to give a maximum up to 25% discount in an insurance premium for renewing P. I. Policy to our members as compared to our fees in the past 3 years. We are aware that several organizations are trying to copy our policy and claim to provide all features of our policy at lower price. We would caution of a claim against you. We request all members to look for values and not for premium. As stated, and in view of the New Consumer Protection Act making the probability of higher sums being awarded against doctors.

We request the members to increase their sum assured and we recommend minimum cover of 2 crores for surgeons and Rs. 1.25 crores for physicians.

We have taken action against one insurance adviser and are examining their service records closely to ensure better action. We would urge members to keep a track of their renewal premiums/receipts/policy copies through their scheme advisers and complain to us at <a href="mailto:supportmlc@amcmumbai.org">supportmlc@amcmumbai.org</a> if they are failed to extend support services.

In addition to the medico legal issues the Medico legal cell has also kept a close watch on issues relating to the medical profession. We have intervened in the Supreme Court in the Appeal filed by R.G. stone clinic against an order of the National Consumer forum holding pre-printed consent forms as unfair trade practice. We do hope to put forth a strong case against the same as the implications of this judgment can be huge for all of us. We have filed WP in P.I.LITIGATION against the Government of India allowing Ayush doctors to perform specific surgeries. Furthermore we have intervened in one WP filed by DELHI Doctors Forum in respect of criminal cases being filed for medical negligence against doctors without the opinion of medical board which is a violation of the Jacob Mathew judgment of the Supreme court.

It is pertinent to note that AMC MEDICO LEGAL CELL supported SEMINAR organised by Centre For Mediation & Conciliation on 'DISPUTE RESOLUTION FOR MEDICO-LEGAL SECTOR" for faster disposal of complaints. Our Advisor Dr Lalit Kapoor has been invited to give lectures at the National training Academy of Judicial officers.

We supported our members for all issues related to the hospital. The main concern this year was of MPCB renewal. As the Hospital renewal is connected with MPCB renewal many hospitals renewal got delayed for which request was made to delink the MPCB renewal with hospital registration renewal. President madam created a special MPCB team for this issue. Meeting was held with CM regarding it. They assured to form a committee related to it. Few Hospitals have agreed to give their biomedical waste for examination, to create a study document to prove that hospital waste is not that hazardous. So that need of establishing the STP ETP can be removed from the requirements list for renewal for MPCB. The biggest hurdle faced was that the pollution Control act is a central act and hence whatever the Central pollution board creates in form of rules and regulations has to be followed by state. Inspite of convincing the officials that in city of Mumbai hospitals will not be able to establish STP ETP was most of the nursing homes are running in co-operative housing society. In meantime Adv Rui Rodrigues was asked to start preparing PIL against this MPCB renewal requirements of STP ETP so that if talks fail we will approach the court for stay and help of members to get MPCB renewal. Several other issues were attempted to be streamlined like CA certificate, charges on consent etc.

Fire, structural Audit, Stablility certificate guidance were given to members as and when they required.

# **Understanding the Indian Healthcare Media**

In the last few years, news reporting on healthcare has increased tenfold owing to the pandemic that has made citizens more conscious and curious about health. In addition, the Government's focus on the sector has also grabbed eyeballs. From a PR standpoint, the mainline publications have mainly focused reporting on listed healthcare and pharma brands and any latest announcements such as vaccine roll outs among others. Mainstream media has also been covering stories that converge public interest and lifestyle. Promotional content and campaigns have been redirected to the paid route. Trade healthcare media is more receptive to cover B2B healthcare organisations and is targeted towards the medical community who read medical news and doctor led articles.

After going through a complete online media audit for AMC, we started creating visibility through healthcare portals and strive to be featured in bigger publications as we move forward. This has not only promoted AMC's work in the media but also helped in building AMC's media relations with the journalists. The objective was to garner media visibility for the Association of Medical Consultants, Mumbai and tell our stories through traditional and social media.

Over the course of 9 months, we have drafted and disseminated a total of **4 press releases** and garnered interest for **3 opinion pieces** by our AMC leadership team. The PR efforts has resulted in a coverage of approximately <a href="25">25</a> clips across mainstream, business and healthcare trade media.

It is Important to be relevant and we have been constantly leveraging our social media platforms to showcase our messaging – <u>135 creatives</u> were shared across Instagram, FB and Twitter.

Besides we organised a Thought leadership program **AMC SOCH**, 7<sup>th</sup> in the series of AMC SOCH- Stakeholders' Outreach Conclave in Healthcare along with Team AMC 22-23, on 12<sup>th</sup> Feb 2023,addressing the relevant topic of UHI and its implementation, along with ABHA registration. 




