**ELIGIBILITY CRITERIA:**

**For President-Elect and Vice President:**

1. President-Elect: Minimum 5 years as an office bearer, with at least one year as Hon. Secretary or Treasurer.
2. Vice President: Minimum 4 years as an office bearer, with at least one year as Hon. Secretary or Treasurer.
3. No pending dues at the time of nomination.

**For Other Office Bearers:**

1. Hon. Secretary: Minimum 3 years as an office bearer.
2. Treasurer: Minimum 2 years as an office bearer.
3. Other Office Bearers Post-Minimum 3 years as an elected member in the Managing Committee.
4. No pending dues at the time of nomination.

**For Area Representative:**

1. For Managing Committee Member's post, minimum duration of AMC Mumbai membership is for 12 months, with no dues.
2. One can contest for Area Representative only from the area, as per one's mailing address as on Dec.31, 2024 in AMC records.

One can file nominations for any number of posts, but can contest only for one post of Area Representative & / or one post of Office Bearer. **[Separate forms must be submitted for 2 different nominations.]** Xerox copy of the nomination form may be used in such a case.

**CODE OF CONDUCT FOR THE CONTESTANTS FOR ONLINE VOTING FOR OFFICE BEARER AND  
MANAGING COMMITTEE POSTS 2025-26**

The Code of Conduct becomes effective on **11<sup>th</sup> March 2025** and will continue till the announcement of results at AGM on **30<sup>th</sup> March 2025**.

The candidates and their supporters should adhere to all moral standards during their campaign and show respect and courtesy to one another, conduct themselves with fair play and ethics.

- 1) No negative campaigning by the candidates is allowed
- 2) Campaigning can be done via social media such as SMS, WhatsApp, Email and Facebook.
- 3) Campaigning cannot be done on the official AMC WhatsApp groups

There are area wise official AMC WhatsApp groups. Campaigning cannot be done on these WhatsApp groups either by the candidate or their supporters. In case a candidate is found canvassing on these groups their name will be removed temporarily until the declaration of result and will be added back on **1st April 2023**. The similar procedure will be followed for a member doing campaigning for a particular candidate in the AMC WhatsApp group. In this interim period should a member temporarily removed wish to send an official message to the other members in the group he can send it via the admin – AMC office.

AMC office will send out one email to all the members before the start of the elections notifying the candidates

- 4) At no cost should AMC finances be used for campaigning.
- 5) If any complaint is received against any candidate, then the decision regarding the candidature of the candidate is the prerogative of the Returning Officers and will be binding.

## **OUR NEW RESOULATIONS FOR 2023-2024**

- 1) Introduction of the floater policy based on the demand of the members in the last 2 AGMs since 1<sup>st</sup> October 2022.
- 2) Dependant parents to be kept in a separate Individual policy as the premium of floater is adjusted to the highest age in the group and the premium as becoming too high. Hence parents put in a separate policy. Parent's premium will be adjusted according to the claim ratio of the group.
- 3) Co-payment of 10% above age of 55 years for all the cases excluding capping disorders/diseases shall continue.
- 4) For members in the floater policy eligible CSI will be as per the CSI in the expired policy of 2022-23 and standard waiting periods on sum enhanced will apply. There are 4 capped ailments and 8 more ailments which have waiting periods on Sum Enhanced. The details of these are available in the brochure.
- 5) Premia are suitably re organised according to age groups as per terms and conditions of the floater policy.
- 6) It has been noticed that we are receiving claims of very high valuation. If this trend continues the premiums will have to go up significantly.
- 7) Age limit for dependents raised to 70 years from 60 years.
- 8) Completed age will be considered for insurance; instead of running age.
- 9) Minimum CSI allowed is 5 lacs for floater and 3 lacs for parents.
- 10) Bed eligibility is uniformly 1% of CSI with sub-limits for 20 lac and above.
- 11) Floater policy upto 20 lacs with Super top up policy upto 10 lacs introduced this year for overall benefit of the members. This was increased to up to 30 lacs for Floater. The top up policy was discontinued as it did not offer any real benefits.
- 12) Accident Insurance policy continues as before and the amounts are increased to 30 Lacs with weekly benefits of Rs 20,000 per week for 20 lac and above policy. Accident policy is now not given for parents.

## Medicolegal Cell Report 2024-2025

Dear Members

As I sign off on this Annual Report of 2024-25 and my tenure as the Chairman of the Medicolegal cell, I can proudly state that I will be handing over charge to a worthy successor Dr Niranjan Agarwal. I can also state that during my tenure I have made a conscious effort to make our Cell and our Professional Indemnity scheme more member friendly. In my 9 years as Chairman I was able to convince the Insurance company to reduce the charges by as much as 40% not once but 3 times in 9 years. This year too we have passed on a 10% discount to the members on their charges paid for the indemnity insurance. A significant portion of the discount received was passed on to members and the rest was utilized for creating a Medicolegal corpus which is now a very healthy corpus.

We found that the insurance company was delaying the payments to lawyers for the services provided to our members and often members were pressurized by the lawyers to pay them in advance and claim reimbursement from the insurance company due to the delays which occurred in receiving payments from the company. We therefore have now started making payments to the lawyers for their services from the Medicolegal corpus thus eliminating the bureaucratic red tape which the lawyers encountered and thus our policy is truly cashless.

A number of copy-cat entities/organizations have ventured to offer similar services of indemnity insurance claiming to offer the same features as our scheme. We believe imitation is the best form of flattery but can proudly claim that we are the largest and most time tested group insurance scheme for professional indemnity and we provide truly end to end services with a constant endeavor to provide a meaningful relief to members at the time of a claim and no other policy has matched up to our policy.

We developed an Android and I phone application for our members to be able to renew their Professional indemnity and Error and Omissions policy within a few minutes. This app has been appreciated by most members for its ease of use and also because it provides the members access to their policies and payment details of the last 8 years. We also have a web based application for those who are not comfortable with using their phones for payments or for access to their data.

We also provide members with free ambulance services and also free security cover for 2 days in the event of a threat of mob violence. This service is provided by Jeevan Security and Ambulance service provider. This is a one of a kind service which no other organization or service provider has been able to provide.

Our policy is the only policy which has a track record of making "Out of Court" settlements in indefensible cases and have made such settlements in over 35 cases in the last few years. As is standard these "Out of Court settlements" had a 10% co-payment clause which we have now revised and now any member who has an indemnity cover of above 2 crores will not have to make any co-payment for such "Out of Court" settlements, members with a cover of between 1 crore to 2 crores will make only a 5% co-payment and only those will less than one crore cover will continue to make 10% co-payment for "Out of Court settlements". We therefore request members to consider increasing their sum insured to avail greater security and financial benefits in case they are embroiled in any medicolegal case. **"THERE IS NO CO-PAYMENT FOR LEGAL FEES OR FOR COURT ORDERED PAYMENTS FOR ANY MEMBER"**.

We continue to provide a complimentary cover of 25% over and above the sum insured if the sum insured is exhausted upto a maximum of 50 lakhs.

This year we are considering adding cover from losses from cyber-crimes and also for defending against defamation on social media. This additional cover will be available to our members at a very nominal cost.

In nine years we also filed a number of intervention applications, PILs and Writ petitions in matters concerning our medical fraternity in High court as well as in Supreme court.

Before I end I would like to state that I am deeply indebted to **Dr Lalit Kapoor** whose constant guidance and support helped me to do my bit to make the Medicolegal Cell "THE MOST VIBRANT CELL OF AMC". Obviously this title was earned only because I had the full backing of my cell members and successive Presidents and their teams. I would like to acknowledge the help provided by **Dr Niranjan Agarwal Dr Sujata Rao Dr Smita Sharma Dr Ajit Desai Dr Ashok Shukla** amongst the many others. I am confident that my successor in the cell Dr Niranjan Agarwal will be able to take the cell to greater heights and carry on the work and make our Medicolegal cell the "Go to cell" for any member facing any medicolegal trouble in Mumbai or its adjoining areas.

I will continue to be available to all members should they need my help. JAI AMC. LONG LIVE DOCTORS UNITY.

We are proud to have completed **20** glorious, successful years of conducting the Consultant Benevolent Scheme. Presently, the total number of members enrolled in the scheme is **1573** (till January 2025). Since the inception of the scheme, we are sad to inform you that we have lost **115** members. However, scheme could serve them with Benevolent Fund of a sizable amount. The last member received a contribution of **10, 66, 800/-**. Since the inception, the scheme has disbursed total amount of **Rs. 9, 08, 94, 700/- (Nine Crore Eight Lac Ninety-Four Thousand & Seven Hundred only)** as a Benevolent Fund. Only **93** members had a premature retirement from the scheme because of various reasons. So now there are 1378 Active members in the Cell.

**7** new members have joined the scheme in current year. We are concerned with the inadequate growth of the scheme, inspite of all its tremendous advantages.

We pay homage and sincerely condole the death of our following **Fourteen colleagues** in the scheme this year. On your behalf, the committee has promptly sent out their deepest condolences to the family of the diseased.

One member has been paid benevolent fund towards Total Disability. Four members have been surrendered the scheme.

The benevolent funds that have been paid to the beneficiaries of each of them are mentioned in columns next to their names. We pay this fund in a shortest possible time with simplest of procedure.

In current financial year we have paid total Benevolent Fund of **Rs. 1,55,11,460/- (One Crore Fifty-Five Lac Eleven Thousand Four-Hundred and Sixty Only)**.

Total Corpus of the C.B.S. scheme as on 31st January 2025 is:

- Rs. 5, 98, 35, 564/- lying in the form of fixed deposits
- Beneficiaries of the 8 members were paid Rs. 1,55,11,460/- as benevolent fund due to them. This was disbursed within 1 month with minimal paper work.
- Rs. 1, 47, 000/- in MOD a/c

Thus the total corpus fund for year 2024 becomes Rs. 5, 99, 82, 564 /- (Five Crore Ninety-Nine Lac Eighty-Two Thousand Five Hundred and Sixty-Four only) while Total Corpus of the C.B.S. scheme as on last year i.e. 31st March 2024 was 6, 66, 96, 623/- (Six Crore Sixty-Six Lac Ninety-Six Thousand Six Hundred and Twenty-Three only)

CBS Scheme is a social initiative by AMC for its members. It has a dual advantage both being a mode of investment as well as life cover for the member; it also provides an immediate financial relief to the dependents of the said member, at a very nominal cost.

This committee was validated in an urgent Managing Committee meeting held next day by President Dr Vivek Dwivedi

This committee laid down the following principles of working:

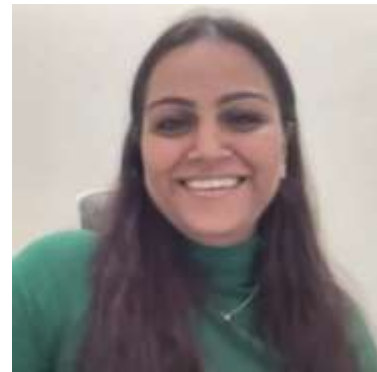

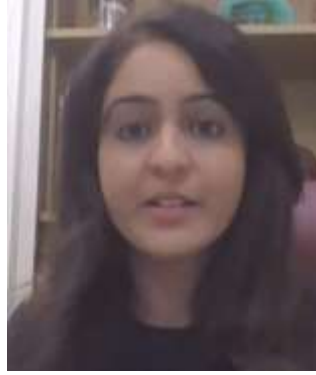

defects and inaccuracies mentioned in the previous audit report have been duly complied with.


- f. All necessary information required by us has been furnished to us by the manager and trustee whenever called upon.

The AMC, Mumbai shall strive to participate in all efforts to improve the health care delivery system in the country. It has the vision of To guide, steer, motivate and hold hands of every practicing Consultant in order to fulfil his medical, ethical and social responsibilities & duties fearlessly and endorse an all encompassing medical education structure, to achieve safe and qualitative healthcare delivery in coordination with other stakeholders of healthcare system.

**Basis of Preparation**

The Balance Sheet and Income and Expenditure account are prepared to comply with generally accepted accounting principles in India to the extent applicable to the Trust. These financial statements are prepared on cash basis. In the absence of any authoritatively established accounting principles for the specialized aspects related to the charitable trusts which do not carry out any commercial activities, these statements have been prepared in accordance with Significant Accounting Policies as described below.

**Method of accounting**

**Fixed assets**

2. All Fixed Assets are stated at cost less depreciation.

**Depreciation**

3. Depreciation has been provide on written down value basis at rates as per Income Tax Act.

**Investments**

4. Investments are stated at cost.No provision is made for dimunition in value of investments as the same are long term in nature and the dimunition in value is not regarded by the Trustees as otherwise than temporary in nature.

**Corpus Fund**

5. Membership receipts are credited to the Corpus Funds appearing in the The Balance Sheet. Donation received with specific direction that they should form a part of Corpus are accounted accordingly.

**Earmarked and other Funds**



6. Donation / contributions received with specific direction/purpose are credited directly to earmarked and other funds in The Balance Sheet. Income from earmarked investments and expenditure on such activities are adjusted to specific earmarked activity funds.

9. Current Liabilities Include Rs.43,39,008.89/- collected from members in respect of legal proceedings undertaken by the trust on behalf of the members. The said amount disclosed as liability till the settlement of the case or such time the outcome is determined.


